Welcome to Minfos 4.1.2

This document provides an overview of the enhancements and support issue fixes in this Minfos release.

Highlights of this release:

- Import and export of minimum order quantities for suppliers
- Attach a note to a product that will appear in Dispense, Till or Ordering
- Dispensing from a Hospital Medication Chart
- Minfos now incorporates the updated AHI fees

How to update Minfos

1. At any point in the day, download the latest Minfos software.
 - a. On the Minfos Launch Pad, click the **File** menu, then click **Minfos Net Terminal**.
The Minfos Net Terminal window is displayed.
 - b. Click the **Connect** menu, then click **1. Internet**. The Online Menu is displayed.
 - c. Check the **1 New Minfos Software** check box, then click **Okay**.
2. When you're finished trading for the day, ensure there are zero connections to your Minfos server.
Your Minfos software will update automatically, overnight.
3. Check that your Minfos software successfully updated. On the Minfos Launch Pad, click the **Help** menu, then click **About Minfos Software**.
The About Minfos Software window is displayed and shows your current Minfos version in the **Applications Versions** box.

Enhancements

This section provides details about enhancements in this release.

Dispense

Dispensing from a Hospital Medication Chart (HMC)

Pharmacists and dispense technicians now have the ability to dispense directly from a compliant HMC. Please contact Minfos support if the hospital you service is rolling out compliant HMCs.

Eligible NRMC items are now displayed in Dispense

Minfos now displays eligible PBS items in the Drug Recall window when dispensing from an NRMC.


Stock Manager

Import and export Minimum Order Quantities (MOQ)

Stock Controllers can now import a file for a supplier (or from a supplier) with the MOQ for their associated products. This information can also be exported. For more details, read the [Import and Export Minimum Order Quantities for Suppliers Guide](#).

From **Stock Manager**, click the **File** menu and select one of the following options:

- Import Min Order Quantities
- Export Min Order Quantities



For both importing and exporting a file:

- The file path of the file can be selected
- The supplier can be selected by either supplier code or supplier name
- The MOQ can be matched to either MNPN or Supplier PDE

When importing a file it is important that the **Import Criteria** setting is configured correctly to match the content of the file. For example, if the import file is provided using the MOQ matched to MNPN, this must be reflected in the import setting.

File Format

The MOQ import and export file is in the form of a text file of two columns separated by a space:

- The left side column is either the MNPN or Supplier PDE
- The right side column is the minimum order quantity


i When importing a file, only products contained within the file will be updated.

Attach a note to a product to prompt in Dispense, Till or Ordering

Stock Controllers can now configure the **Product Info** window to prompt in the Dispense form, Order Maintenance and the Till.

This can be useful in alerting the pharmacy staff to a specific action that might need to be taken for that product. For example, short dated products, products that are no longer stocked, or products that are, or are about to be, discontinued.

To set up the prompt, click the **Info** button in **Product Maintenance**.



Product Quick Fix - Order number

You can now use **Product Quick Fix**, and sort by the unique Minfos Order Number, to make bulk changes to the products in the order.

Product Quick Fix - new SOH column

Stock On Hand (SOH) is now visible when viewing products in **Product Quick Fix**. Stock Controllers can now be sure they are actioning products that have SOH (for both positive and negative values) and to action the product appropriately.

Product Quick Fix - A.R product code

Stock Controllers can now use **Product Quick Fix** to change the AR Product Code via a category to help ensure products are correct for ordering. For example, S3 products can be assigned, in bulk, to a different AR product code.

Option to import alternate suppliers with product updates

Currently, when a supplier file is imported, ALL alternate suppliers are added to the store and all relevant products updated.

The new checkbox called **Alt. Supplier Info** allows stock controllers to choose whether alternate supplier information will be updated against products.

M.N.P.N. 2 Updates

Select the type of update Company or Supplier, and the required Company/Supplier. The system will run Minfos Net Terminal and then Import the MNP Update.

This option imports MNP updates, if the products can not be matched by name they will be added and you will need to merge your existing products to the new MNP ones. This option is ONLY for MNP sites. If unsure please check with support.

Alt. Supplier Information (If Ticked this will update alternate supplier information)

When the checkbox is ticked, all alternate suppliers will be imported and the products updated, as per current functionality.

When the checkbox is not ticked:

- Only supplier information, for the supplier selected for the MNP update, will be imported
- You will not be able to view updated alternate supplier information such as:
 - The list of other suppliers that supply the product
 - The list price for other suppliers

Additionally, you will not be able to update best buys for other suppliers.

Price Manager

Access Price Manager from Order Maintenance

Price manager can now be launched directly from the **Order Maintenance** window by clicking the **Price Manager** button, saving time spent navigating between windows.

Support issues resolved

This section provides details about support issues resolved in this release.

Dispense

- In line with the 6th Community Pharmacy Agreement (6CPA), Minfos now incorporates the updated AHI fees effective from 1 July 2016, when calculating dispense prices for broken packs, DVA unlisted and chemo items. All other items were updated as part of the July dispense update. For more information and a list of fee updates, read the [PBS AHI fact sheet](#).
- Pressing [F2] on the Dispense form **Surname** field now clears all fields.
- When navigating Dispense using [Shift] + [Tab] or [Arrow up], the cursor will now allow navigation past the CTG field.
- Minfos no longer prompts that the Safety Net limit is reached for REG25 scripts.
- For entitlement repat patients, the serial number is now printing with the correct lower case "r".
- A DOB prompt is no longer displayed when an S8 is dispensed as part of a doctor's bag.

Stock Manager

- If the merge of two products in **Product Maintenance** will result in more than 64 alternate barcodes, the merge will not proceed and a warning prompt is displayed.
- Printing **Labels by Range** now works as expected.
- Printing large numbers of labels in **Labels By Range** now prints correctly.

Order Maintenance

- When cancelling out of the **Merge** window, the screen now returns to the **Order Maintenance** window instead of the POS Maintenance screen.

Price Manager

- Products on Promotion now display in pink in **Price Manager**.
- Discontinued products are now coloured grey in **Price Manager**.

Reporting

- Refunding a sale on a promotional item, no longer produces a large negative GP% in the Top Selling / Worst Selling Reports.

Promotions

- Refunding a product on a promotion no longer records as a discount sale.

Promo Wizard

- When importing a promotion in previous versions, a conflicting promotion code would result in deletion of the old promotion along with the promotion code before importing the new promotion.

Now, if the new promotion has different content (for example, one is locally created and one is from Head Office), Minfos will retain both promotions, with the local promotion given a new promo ID.
